#### Sonoma County Says No to Measure J

While the results are just starting to come in, it is clear that Sonoma County voters stood strong and made a resounding statement by overwhelmingly rejecting Measure J. Thank you for your unflagging support throughout the campaign and this shows the power of what we can do when we come together as an industry.

Western United Dairies formed a new Political Action Committee, Sonoma United, to fight Measure J in Sonoma County. In coordination with other "No on J" efforts, we executed a highly targeted direct voter campaign using a combination of direct mail, digital ads, social media, text messages, and grassroots outreach featuring our members, local business owners, and other coalition partners.

- Polling: Conducted initial polling to understand the landscape and identify the most impactful and persuasive messages and messengers for use in guiding development of our direct voter contact specifics and targeting.
- **Direct Mail:** Five mailers highlighting Measure J's impact on the local dairy community were sent to registered voters in approximately 72,000 households between late September and late October.
- Digital Advertising: Six-week digital advertising effort targeted at voters in Sonoma County utilizing a combination of social media, display advertisements and pre-roll videos. Specific social media sites include Facebook, Instagram and YouTube, and programmatic display and preroll video on Pressdemocrat.com, Sonoma County's local newspaper.
- **Texting Program:** Two text messages sent to an identified target universe of approximately 55,000 phone numbers. Messages included a combination of text, images and video.
- Community Resources: Launched a campaign website featuring videos, news, ways to get involved/stay connected and a community toolkit with additional resources, frequently asked questions and fast facts about the campaign.

# CDFA Releases New HPAI Frequently Asked Questions Guide

The California departments of Food & Agriculture, Public Health, Industrial Relations, Cal-OSHA as well as the Labor and Workforce Development Agency and Cal OES are working together to identify and eliminate bird flu in dairy herds, poultry, and domestic and wild animals. The state is also working to minimize any illness in humans by detecting, treating, and investigating possible cases, by implementing preventive measures, and by executing timely public education efforts. 



### WEEKLY MARKET UPDATE

US dairy exports were strong in September, with all commodities showing year-over-year gains. Outbound total cheese volumes rose 7% versus 2023, with Mexico's purchases up 19%. Butter exports leapt 23%, while imports reached an all-time high of 15.9 million pounds.

- CME cheddar markets tumbled lower amid soso demand and ample US milk flows. Spot blocks fell to the upper \$1.70s, while barrels slipped to the low \$1.80s. On the heels of the spot cheese market declines, 2025 Class III futures have been dropping. Producers who have not secured milk price protection may want to take a look.
- In Chicago, the CME butter market remains quiet amid well-balanced supply and demand.
  There hasn't been much news to bump the market very far in either direction, and prices are comfortable in the \$2.60s.
- USDA's September Dairy Products report showed butter output remains well above prior-year levels. Production dipped slightly on the month at a time of year when output usually increases, but the difference from average was negligible.

- Cheese production remained relatively tight, largely unchanged on the year, but down more than average on a month-to-month basis.
- Milk powder output ticked up on the month and was down only slightly versus 2023.
- All commodity prices jumped higher at this week's GlobalDairyTrade auction as volumes declined. Skim milk powder rose 3.8% to \$1.29 per pound, while whole milk powder advanced 4.5% to \$1.68 per pound.
- The jump in GDT prices and decent export data gave the CME nonfat dry milk market a little spark, pushing it closer to the \$1.40-perpound mark.
- US corn and soybean harvests are nearing completion, at 91% and 94%, respectively.
